1 DEFINITIONS

The following terms shall have the meaning set out opposite them below, unless the context otherwise requires:

Attendee	Means a person who attends the Event (Supporter or Participant);
Administration Fees	Booking Fee plus the Processing Fee;
Booking Fee	the top up administration fee charged on bookings for all team packages (not Solos). This is non refundable;
Charity Place	means a part-funded place whereby the participant pays a portion of the Entry Fee and the Charity pays the remaining amount;
Event	Means any event listed under “Endure24” 2025 organised by Threshold Sports Ltd;
Entry Fee	the fee that must be paid per package to gain secure entry on the Event;
Event Email Address	Means info@endure24.co.uk;
Event Website	means the official Event website hosted by or on behalf of Threshold found at www.endure24.co.uk ;
Force Majeure Event	means any circumstances beyond the reasonable control of a party affecting the performance by that party of its obligations under this Agreement including inclement weather conditions, serious fire, storm, flood, lightning, earthquake, explosion, acts of a public enemy, terrorism, war, military operations, insurrection, sabotage, civil disorder, government order, pandemic, epidemic, embargoes and labour disputes of a person other than such party
Fundraising Pledge	means the minimum amount of fundraising pledged as part of a charity place;
Organiser	means Threshold Sports Ltd;
Processing Fee	the baseline administration fee charged for each registration or any change made to a registration with its value based on the total purchase amount in the basket. This is non refundable;
Solo Participant	A participant place secured for a Solo Runner. The solo runner must be 18 yrs or older, complete Registration and pay the Entry Fee plus administration Fees to secure their place;
Supporter	A person of the age of 6 or over who will be attending the event to support their Solo or Team Participant, subject to obtaining a pass from their Team or Solo Participant. They will not be participating in the Endure 24 running Event (with the exception of the Mini Mile);
Supporter Pass	A pass, that allows the Supporter access to the Event.
Team Captain	A Participant who registers themselves and their Team name and pays the Entry Fees plus administration Fees on behalf of each participant within their Team of 2 or more;

Team Participant	A member of a Team of 2 or more, who has completed their own Registration via the email link received from their Team Captain;
Partner Charity	a charity that has agreed to part-fund participant places on the Event
Registration Form	the form that needs to be completed online by applicants to confirm their participation on the Event;
Endure24 Series	Means Endure24 Leeds and Endure24 Reading Events;
Let's Do This Customer Service Email Address	Means support@letsdothis.com.

2 TERMS AND CONDITIONS

- 2.1 By registering for, participating in, attending or accessing the Event and/or using this Website, you confirm that you have read and agree to be bound by these terms and conditions and such other terms as may be drawn to your attention by the Organiser. We may vary these terms and conditions at any time and such modifications will become effective immediately upon posting of the modified terms on the Website. By continuing to use the Website or participating or accessing the Event following any such variation, you will be deemed to have accepted such variation
- 2.2 You are solely responsible for any loss or damage caused by you or a member of your Supporter Group. In the event that the Event land owner or other supplier brings any claim against us or otherwise seeks to recover any loss or damage against us resulting from your actions, you will be responsible for meeting such claims
- 2.3 If you or any member(s) of your party are in breach of any of these terms and conditions, infringe the rights of any third parties or contravene any applicable law or regulation we reserve the right to cancel your booking without refund or compensation, to halt your participation in the Event, to refuse admission to the Event site or eject you from it. We shall not be liable for any loss, damage or expense resulting from your incorrect, incomplete or missing documentation or non-compliance with official requirements including those set out herein.
- 2.4 If any provision in these Terms and Conditions, whether in full or in part, is held to be invalid or unenforceable, all other remaining provisions (in full or in part) shall continue to be valid and enforceable.
- 2.5 These Terms and Conditions shall be interpreted in accordance with the laws of England and Wales and any dispute arising hereunder shall be subject to the exclusive jurisdiction of the English courts.

3 REGISTRATION

- 3.1.1 Only persons aged 18 years or above on the first day of the Event, may take part in the Solo or Pairs Categories.
- 3.1.2 Persons aged 16 or 17 are able to take part in the Teams (of 3 and above) Category.
- 3.1.3 Persons aged 15 or below are unable to participate in the Event either as a Solo or Team Participant.
- 3.1.4 At least one member of each Team must be 18 or over at the date of the Event.
- 3.1.5 Solo Applicants must complete and submit the Registration Form which can be found at Event Website, and pay the Entry Fee and Administration Fees
- 3.1.6 Team Captain Applicants must complete and submit the Registration Form which can be found at the Event Website and pay the Entry Fees and Administration Fees for the entire team. Once registered the Team Captain must invite Team members to register via the registration platform.

- 3.1.7 Team member Applicants must complete and submit their own Registration Form which can be accessed via the Email confirmation link provided by their Team Captains.
- 3.1.8 All successful applicants (hereinafter referred to as "Participants") will be notified by way of an Email Confirmation (the "Email Confirmation") that they have been allocated a place to take part in the Event.
- 3.2 Places in the Event are strictly limited and therefore applications are subject to availability. Subject to Clauses 3.1 to 3.5 The Organiser will consider applications on a first come, first served basis by eligible Participants (which the Organiser shall determine in its absolute discretion) and otherwise in accordance with these Terms and Conditions
- 3.3 The relevant date for registrations shall be the date the Participant receives their own Email Confirmation. The Organiser is not responsible for technical, hardware or software failures of any kind, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer/Internet transmissions or other errors or malfunctions of any kind which may prevent receipt by the Organiser of a Registration Form or receipt by an applicant of an Email Confirmation.
- 3.4 For the avoidance of doubt, if, for any reason whatsoever, an applicant does not receive a personal Email Confirmation, said applicant shall not be considered to be a Participant and the Organiser shall not be responsible for the applicant's failed application.
- 3.5 The deadline for all Registrations on the online Platform is 23:59 on the Sunday 2 weeks prior to the Event. After this deadline The Organiser can accept new registrations up until 11.00 am at the Information Desk on the Saturday of the Event. The Organiser cannot be held responsible for any circumstances that causes a Participant to miss this deadline.
- 3.6 This deadline is subject to change if the Event entries are full prior to the above date. Threshold reserves the right to close the Registration Form at any point.
- 3.7 The Organiser cannot guarantee availability of places, medals and T-shirts for new registrations made after the online Platform deadline.

4 ENTRY FEES

- 4.1 The Entry Fees are as set out on the Event Website. The Entry Fee may vary depending upon geographic market, availability, selected package, venue requirements and/or regulations and we reserve the right to change prices at any time. All Entry Fees are inclusive of VAT.
- 4.2 Subject to the other provisions of Clause 2 submission of the Registration Form, payment of the Entry Fee and the Administration Fees, and receipt of the Email Confirmation shall (together) entitle the Participant to participate in the Event.
- 4.3 The Event is personal to the Participant accepting these Terms and Conditions, and the Participant undertakes and agrees (i) only to participate in the Event wearing the number assigned to their registration, (ii) not to authorise or permit any third party to use their Participant number for the Event and (iii) not to sell, transfer or give any other person the right to participate in the Event and/or use the Participant's number, with the exception of compliance with Clause 6.4.
- 4.4 If at any time it is discovered that any Participant should have been ineligible to participate in the Event or if participation in the Event should have been refused for any reason whatsoever, the Organiser reserves the right to disqualify such Participant from/refuse such Participant entry to the Event.
- 4.5 The Organiser reserves the right to reject at any time any Registration Form which it believes to be fraudulent, or to disqualify at any time any Attendee it believes not to have fully complied with these Terms and Conditions from participating in, or attending the Event, or in any future events delivered by the Organiser. The Organiser shall not be liable in any way to such Attendee as a result of any such disqualification or refusal. It is the Attendee's responsibility to ensure full compliance with these Terms and Conditions.

5 ADD-ONS

- 5.1 Team Captains, Solo Participants and Team Participants are able to purchase 'Add-ons' via the online registration platform.
- 5.2 Administration fees will not be charged on Add-ons booked by registered Participants.
- 5.3 Add- Ons purchased that are managed by the Organiser such as Supporter Passes will be refunded in full upto the Entry Deadline which is 23:59 on the Sunday 2 weeks prior to the Event.
- 5.4 Add- Ons purchased from third parties such as merchandise, photos, registration insurance and glamping are subject to those third parties Terms and Conditions.
- 5.5 Supporter passes can be booked in advance of the Event by registered participants. Supporters who do not have a pre-booked pass through a Participant will be able to purchase a Supporter pass from the Information desk on the day.
- 5.6 Supporter Passes are not required for children aged 5 and under.
- 5.7 Supporter Passes are not required after 10am on the Sunday of the Event.
- 5.8 The Participant is responsible for passing on the Email confirmation to their Supporters. Supporters will only gain access to the Event village with a Supporter Pass or Email confirmation of the purchase. The Email confirmation includes a link to these Event Terms and Conditions, which Supporters will be required to read as a condition of access to the Event. By attending the Event village, each Supporter will be deemed to have agreed to and accepted these Terms and Conditions.
- 5.9 It is the Participant's responsibility that their Supporters, adhere to the Terms and Conditions of the Event if they have purchased the Supporter Pass on their behalf.

6 REFUND, CANCELLATION AND TRANSFER OPTIONS

- 6.1 The Organiser operates a 14-day cooling off period. Accordingly, if the Solo Participant or Team Captain cancels their entry within this period, they will receive a refund of the Entry Fee. To be eligible for this refund, the email cancelling the entry must be received within 14 days of confirmation of entry from the Organiser..
- 6.2 To cancel a place in the Event, the Participant must let us know by emailing the Organiser at the Event Email Address. This should be done as soon as possible and before the day of the event. Please note:
 - 6.2.1 The Entry Fee is non-refundable after the 14 day cooling off period.
 - 6.2.2 The Administration Fee is always non-refundable.
 - 6.2.3 Add-ons will be refunded as per with Clause 5.3 and 5.4.
- 6.3 In the event of a cancellation of the Event, whether due to a Force Majeure Event or otherwise, the Participant will have the option to receive a full refund of their Entry Fee paid to date, less the Booking Fee. Other than the obligation to make payment of any such refund in the above circumstances, the Organiser will be not be liable for any failure to perform its obligations under this Agreement if and to the extent that such failure was caused by a Force Majeure Event.

6.4 PARTICIPANT TRANSFER

- 6.4.1 A Participant can transfer their entry to another individual ("Participant Transfer") if notice is given to the Organiser and subject to 6.4.2 to 6.4.3.
- 6.4.2 Solo and Team Participant Transfers can only take place if the new Participant wishes to take the same Event Package.

- 6.4.3 The deadline for all Participant Transfers on the online Registration Platform is 23:59 on the Sunday 2 weeks prior to the Event. After this deadline. The Organiser can accept changes up until 11am on the Saturday of the Event, for exceptional circumstances at the Information Desk. The Organiser cannot be held responsible for any circumstances that causes a Participant to miss this deadline.
- 6.4.4 Notice of a Solo Participant Transfer must be done via the Registration Platform. The incoming participant must pay a £25 transfer fee to register. Participants must arrange payments between themselves. No refunds are given.
- 6.4.5 Notice of a Transfer of a Team Participant who is registered as part of a Team of 2 or more, must be given to Let's Do This or the Organiser by anyone within the team, at the Let's Do This customer support email address support@letsdothis.com.. The outgoing participant entry will then be cancelled and the Team Captain will send the new participant an invite link to register on the Let's Do This platform. The Team Captain is responsible for re-allocating monies between the incoming and outgoing Team Participants.
- 6.4.6 For Solo Participant Transfers the most current Entry Fee and Administration Fee is applied at checkout when the new Participant accepts the transfer.
- 6.4.7 For Solo and Team Participant Transfers, there are no administration Fees applied to the original participant or Team to action the Transfer
- 6.4.8 Add-ons purchased by the outgoing Participant are not transferred to the incoming Participant and will be refunded to the outgoing Participant as per clause 5.3 and 5.4
- 6.4.9 Notice of a Charity Participant Transfer must be done via charities@thresholdsports.co.uk: before 23.59 on the Sunday prior to the Event

6.5 PARTICIPANT DEFERRAL

- 6.5.1 A Solo Participant is permitted to defer their entry ("Deferral") to the following year if notice is given to Let's Do This and the Organiser via the Let's Do This platform subject to a fee ("Deferral Fee", see below), payable prior to the following year's event. The Organiser will not be able to refund the Entry fee or Administration Fees. Notice of the Participant Deferral must be given via Registration Platform as per 6.5.4. Let's Do This or the Organiser will then cancel the place in the Event. Following the launch of the following year's Event the Organiser will provide the deferred Participant with a link to register, with the deferral fee to be paid.. The link will be sent via email to sign up to the following year's Event.
- 6.5.2 The deadlines and associated Administration Fee for this are:
- Up to 23:59 on the Sunday 4 weeks prior to the Event for General Entry and Charity Entry.
 - There is no immediate cost to defer. Upon signing up for 2026 events, the participant will be required to pay the £25 deferral fee.
- 6.5.3 A Team Captain is permitted to defer the entry of their entire team ("Deferral") to the following year if notice is given to Let's Do This or the Organiser. The Organiser will not be able to refund the Entry Fee or Administration Fees. Notice of the Participant Deferral must be given via Registration Platform or the Event Organiser as per 6.5.4. The Organiser will then cancel the Team in the Event. Following the launch of the following year's Event the Organiser will provide the deferred Team Captain with a sign-up link, where participants will be required to pay the £25 deferral fee. The link will be sent via email to sign up to the following year's Event against a Team entry of equal size.
- 6.5.4 A participant or team can only defer their entry once.
- 6.5.5 Notice to defer for charity places must be shared with the charities@thresholdsports.co.uk team
- 6.5.6 Notice of a Team Deferral must be done via via the Let's Do This (support@letsdothis.com) or Event Organiser customer service team(s). The deadlines and associated Administration Fee for this are:

7 Up to 23:59 on the Sunday 4 weeks prior the Event.

8 There will be no immediate cost to defer. Upon signing up for 2026 events, the participant will be required to pay the £25 per person deferral fee.

8.1.1 The Solo Participant or Team Captain will need to pay the difference in cost if there is an upsize to the desired Entry Category in the following year. No refund will be made if the desired Entry Category price is less in the following year.

8.1.2 Deferrals can not be processed within 4 weeks of the Event.

8.1.3 Deferrals are subject to availability of places on the Event in the following year but deferred places will be given priority when registration opens

8.1.4 Deferrals can not be processed for individuals within a Team

8.1.5 Add-ons including Supporter Passes purchased will be refunded in line with Clauses 5.3-5.4 They cannot be deferred.

8.1.6 If a Solo Participant wishes to change their Category, Team Size or Package, it is the responsibility of the Participant to complete the steps outlined in Clause 6.7 once they have completed the Registration Form for the following year.

8.1.7 The Participant understands that once a deferral has been processed, the original administration Fees are non refundable under any circumstances

8.2 EVENT TRANSFER

8.2.1 A Solo Participant can transfer their entry, and a Team Captain can transfer their entire Team entry from Endure24 Reading to Endure24 Leeds in the same year, and vice versa, if notice is given to Let's Do This or the Organiser via the Let's Do This platform.

8.2.2 Charities entries are able to transfer, however it is not guaranteed that their chosen charity on one event will be available on the other

8.2.3 Notice to transfer must be shared with the charities@thresholdsports.co.uk team

8.2.4 Notice of an Event Transfer for Charity participants must be made by:

- Up to 23:59 on the Sunday 4 weeks prior to the Event

8.2.5 Notice of an Event Transfer ("Event Transfer") must be done via the Registration platform and made by:

- Up to 23:59 on the Sunday 2 weeks prior to the first Event.

8.2.6 Add-ons purchased will be refunded in line with Clauses 5.3 and 5.4

8.2.7 Event Transfers are not possible between years.

8.3 CHANGING TEAM SIZE (CATEGORY)

8.3.1 A team size can be increased by the new participant purchasing a 'Join an existing team' ticket via the Let's Do This registration platform.

8.3.2 A Team Captain can increase the size of their team by adding more Participants to their team on the registration platform, and is subject to availability.

- 8.3.3 The deadline for all Team Size changes on the online Registration Platform is 23:59 on the Sunday 2 weeks prior to the Event. After this deadline The Organiser can accept changes up until 11am at the Information Desk on the Saturday of the Event. The Organiser cannot be held responsible for any circumstances that causes a Participant to miss this deadline.
- 8.3.4 The Organiser cannot guarantee availability of places, medals and T-shirts for additional team members registered after the online Registration Platform deadline.
- 8.3.5 If the Team Captain or Solo Participant is changing Team size to another Team size that has a lower Entry Fee they will not be refunded the difference in these packages.
- 8.3.6 If the Team Captain or Solo Participant is changing Team size to another Team size that has a higher Entry Fee, the difference in Entry Fee plus any incremental Administration Fees for making the change must be paid via the Organiser by the Team Captain, before the Organiser will recognise the Category change.
- 8.3.7 If the Team Captain or Solo Participant entered using a free of charge code or deferral link, please contact the Event Email Address to facilitate this change of category

9 CHARITY PLACES & FUNDRAISING DECLARATION

- 9.1 If taking part via a Charity Place, the Participant (including Solo Participant, Team Captain and individual Team Participants) are required to fundraise a minimum of £300 or the figure agreed by the charity.
- 9.2 All team members are required to fundraise for the same charity as the Team Captain, and upon registering must select the same charity which the Team Captain is required to enforce.
- 9.3 The Participant is required to reach at least 50% of the fundraising target at least 4 weeks prior to the Event. If registering within 4 weeks of the Event, the Participant must raise 50% of the target 2 weeks prior to the Event. Failure to do this can result in the removal from the Event.
- 9.4 The Participant is required to reach the full fundraising target no later than 4 weeks after the Event.
- 9.5 If the Participant would like to fundraise for a Charity that is currently not listed on the Registration Form, the Participant must first receive confirmation from both the Organiser and the chosen charity before beginning to fundraise.
- 9.6 If taking part via a Charity Place, the Participant is opting in to share personal data with the chosen Charity and are agreeing to be contacted by the charity in relation to participation in the event. This is of the understanding that the charity will not share your personal data with any third party for marketing purposes.
- 9.7 If taking part via a Gold Charity Place, the Participant is opting in to share personal data with the chosen charity and are agreeing to be contacted by the charity in relation to participation in the event and other Threshold Sports Events in which the charity is associated with. This is of the understanding that the chosen charity will not share your personal data with any third party for marketing purposes.
- 9.8 Please note, that by taking part via a Charity Place, this incurs a cost to the charity. This cost and fundraising model is agreed in advance with the charity and is on the basis that the minimum fundraising target will be reached. For further details on the exact costs incurred, please contact the charity directly.
- 9.9 If the Event is cancelled or the participant cancels their place, donations will not be refunded by the charity.
- 9.10 If a participant from a Team does not fundraise or take part in the Event, the responsibility of their fundraising minimum is shared between the remaining members of the Team. The Team Captain acknowledges this responsibility at the point when payment is made to secure the Team at Registration.
- 9.11 If a charity chooses to terminate their partnership with the Event prior to it taking place, the Participant will have the option to upgrade to a fully funded place. Refunds will remain in line with Clause 4, 5 and 6.

10 EVENT RULES

- 10.1 The Organiser reserves the right to change the time, date, route (including reasonable changes to the location) and/or format of the Event, or, in exceptional circumstances, to cancel the Event, in whole or in part, without liability to the Participant or Supporter. In such cases, Threshold:
- 10.1.1 will make a reasonable effort to provide notice of the changes/cancellation via email. If email notice is not practicable due to the timescales involved, we will use reasonable alternative methods of notice including text messages;
 - 10.1.2 will have no responsibility or liability for any costs incurred, including any travel or accommodation costs whether existing or additional, as a result of the changes/cancellation; and
 - 10.1.3 undertakes to act with full transparency and fully observe and satisfy its legal obligations to you at all times.
 - 10.1.4 You may possibly receive a full or partial refund of the Fee, the amount to be determined by us dependent on the circumstances of the cancellation.
- 10.2 Participants are able to take part in the Event as a solo entrant, a pair or part of a team. If in a team, Participants must enter a team name on their Registration Form.
- 10.3 Persons under the age of 18 must be supervised by a responsible Adult, with the only exception being when 16 or 17 year olds are on the course whilst completing their lap as part of a Team of 3 or more.
- 10.4 Persons under the age of 18 must follow the guidance published by the most current UK Athletics rules for competition.
- 10.5 Attendees under the age of 18 are not permitted to consume alcohol at the Event. We reserve the right to remove alcohol from any person who cannot prove that they are over 18.
- 10.6 We cannot accept bookings from, nor attendance by, persons who may reasonably be considered as a risk to the safety or welfare of any other Attendee, or may affect the enjoyment of other patrons and/or the running of the Event, or, in the opinion of the Organiser, may cause damage, nuisance or injury. It is the Participant's responsibility to inform the Organiser if they or any of their Supporter Group are of a character that may fall within the terms of this Clause or is of a character or has exhibited behaviour that would not be deemed appropriate for an event of this nature.
- 10.7 Attendees are responsible for any glass bottles that are brought on site. Broken glass is a danger to both children and others
- 10.8 Should an Attendee not respect and adhere to these Terms and Conditions and any such other terms as may be drawn to their attention by the Organiser, for example as may be displayed at the entrance to the Event site we reserve the right to evict an Attendee without refund
- 10.9 We recommend that you have appropriate and adequate travel insurance and health documentation in place at the time of booking and take the necessary documentation with you.
- 10.10 The Organiser reserves the right to remove any Attendee from the Event, either during or before it, due to ill health, or any other reason (at the Organiser's discretion) that may render the Attendee unfit to safely complete or remain at the Event or unable to participate in a manner which fully complies with any applicable government medical or safety instructions, protocols or guidelines. The Attendee confirms that they will not take part in the Event if they are suffering from any contagious illness (to include, but not exclusively, symptoms suggestive of Covid-19 (or similar) infection and diarrhoea or vomiting symptoms) and confirms that they will report any illness during the Event, to the Event medical team immediately.
- 10.11 Irrespective of any safeguards that may be put in place by the Organiser, Attendance at the Event is at the Attendee's own risk, including risk to the Attendee themselves (in particular with respect to the transmission of infectious diseases, such as Covid-19) and any damage caused by/to third parties or third party property.

- 10.12 Without prejudice to Threshold's right to remove any Attendee from the Event due to ill health pursuant to Clause 8.10 above, the Attendee acknowledges and agrees that:
- 10.12.1 If the Attendee becomes ill with a non-infectious illness (as determined by the Event medical team) during the Event, the Organiser will allow the Attendee to remain on the campsite.
- 10.12.2 If, however, the Attendee becomes ill with an infectious illness (as determined by the Event medical team), the Attendee shall be asked to leave the Event.
- 10.13 A Participant may be disqualified ("Disqualification") from the Event, or the Supporter asked to leave the Event by the Organiser if it is deemed that the Attendee:
- 10.13.1 may cause injury to you or another participant;
- 10.13.2 may damage or harm the environment;
- 10.13.3 in the Organiser's opinion is likely to cause offence; or otherwise causes a risk or potential risk to health and safety including any failure, in whole or in part, to comply with the Terms and Conditions
- 10.13.4 in the Organiser's opinion the Participant is unfit to participate in the Event due to:-
- the consumption or use of alcohol or drugs;
 - an injury or illness; or
 - the Participant fails to arrive at the start location at the specified time;
- 10.14 if the Participant is refused entry to the Event or we ask the Participant to cease participation in the Event, the Participant must remove their runner's identification number and electronic chip and return them to an Event official.
- 10.15 In the event of an Attendee having to leave the Event because of injury, illness, voluntary withdrawal or Disqualification, the Participant will be responsible for all repatriation travel costs and related incurred travel arrangements. The Organiser will not be responsible for transporting the Attendee or any belongings of the Attendee.
- 10.16 The Organiser will endeavour to provide every Participant with a completion time but is not responsible for any electronic timing anomalies.
- 10.17 To protect the integrity of the racing The Organiser will not accept any changes to Teams, Pairs or Solos after the Deadline of 11am on the Saturday of the Event. Any changes requested thereafter will not be accepted or processed
- 10.18 No drugs, illegal substances, performance enhancing substances or intoxicants of any kind are permitted to be used by any Attendee either before or during the Event. The Organiser reserves the right to refuse attendance at, or participation in, the Event by any persons found to have consumed or to have in their possession any drugs, illegal substances, performance enhancing substances or intoxicants of any kind.
- 10.19 As a continuing condition of entry each Participant shall ensure that, for the duration of the Event:
- 10.19.1 Only registered participants in the solo or team running packages are permitted on the course. No supporters are permitted on the course.
- 10.19.2 Solo Participants must always access/leave the course via the Solo Runner entry/exit point in order that the timing system may correctly register the lap.
- 10.19.3 Participants competing as a pair or part of a team must all complete at least one lap. Team Participants must always access/leave the course via the exchange point or risk disqualification. Participants are not required to

have a team member on the course at all times but cannot have more than one team member on the course at the same time.

- The one exception to this is at the end of your final runners' lap. There is an access point approx. 100m before the finish where team members can join their final runner for a team finish. Apart from the final runner, all other team members must remove their timing chips.

- 10.19.4 the Participant understands that the event involves sustained physical exercise in a remote area, and may involve walking or running at night;
- 10.19.5 the Attendee accepts that they are responsible for their own safety during the Event, in particular during the night sections;
- 10.19.6 the Participant follows the Event route signage at all times, and does not deviate from the official signed route of the Event;

The Categories are as follows; Solo Male; Solo Female; Pairs Male; Pairs Female; Pairs Mixed; Small Teams Male; Small Teams Female; Small Teams Mixed; Large Team Male; Large Team Female; Large Team Mixed; XL FUN Team;
- 10.20.1 Small Teams consist of 3-5 runners;

10.20.2 Large Teams consist of 6-8 runners;

10.20.3 XL Fun Teams consist of 9+ runners.

10.20.4 "Number of laps" refers to the number of laps started after 11.59.59am on the Saturday and completed by 12.59.59pm on the Sunday. Please note this allows a maximum of one hour to complete the final lap.

10.20.5 Participants who have selected Non-Binary or Prefer Not To Say will not be eligible for an award in the Solo category.

10.20.6 Participants who have selected Non-Binary or Prefer Not To Say can receive an award if they have entered in a Mixed Pair or Mixed Team categories.

10.20.7 Transgender participants should refer to the [Transgender Participant Guidance](#) when registering.
